Remember – the information contained herein will be used to make up the registration certificate. **BE SURE YOU ARE CORRECT** on the spelling of all names, registrations numbers, the complete foaling date, the accurate description of the animal and the distinguishing markings on the diagrams. **N.B. Please ensure the Descriptions and Whorls page is completed correctly, either by a veterinary surgeon or someone who has sufficient expertise and experience. ALL horses have at least three whorls and applications submitted without whorls noted will be returned as incorrect. Where there are no markings on the any part of the body, please enter 'No Markings'.**

1. NAME OF THE ANIMAL : Two name choices are requested in case one name has already been taken.
PREFIXES: If you already have a prefix, whether registered or unregistered, please fill in the prefix section. If you want a new prefix to be registered please put in 'Unregistered Prefix Section' and add the word "new" in brackets.
2. DATE OF FOALING: Give day, month and year. (If unknown, put U/K).
3. NAME AND NUMBER OF SIRE AND DAM: Give complete name of sire and dam and grandsires and granddames – **ESSENTIAL** for REGISTER ONE and REGISTER TWO. For entry in registers three to seven give name of sire, dam and grandsires and granddames (if known, if unknown put U/K).
4. SERVICE CERTIFICATE: Form at bottom of application must be completed if person owning the dam was NOT the owner of the sire at the time of service. (This does not apply to horses of unknown breeding). But **ESSENTIAL** for Register One: Pure Falabellas and Register Two. Also registers three to seven if breeding known.
5. MEASUREMENT: **World-Wide Measurement.** Measure your horse from the base of the last hair of the mane in centimetres, make sure your horse is standing on level concrete with all feet square. **European Measurement.** Measure in INCHES from the wither to the ground.
6. Be sure to check that your horse is eligible for the section of the register that you are applying for. If in **any** doubt phone office 01376 584552.
7. All applications must be made on official registration form (one per animal) and must be accompanied by the fee of £16 per animal for passports and £10 per animal for registration only. **Please make cheques payable to I.M.H.P. Society Ltd.** UPDATED PARTICULARS WILL BE REQUIRED for registered youngstock on reaching 36 months of age. You will automatically be sent a **Mature Horse** application form when your animal reaches **Mature** age. £16 for animals born after 1998 includes passport.





(TETE et ENCLOSURE VUE VENTRALE)


